## Use of Cookies and Web Beacons

We may use cookies to help you personalize your online experience. Cookies are identifiers that are transferred to your computer's hard drive through your Web browser to enable our systems to recognize your browser. ### **Agreeing to Terms**

If you do not agree to [travstours.com.au](http://travstours.com.au) Privacy Policy as posted here on this website, please do not use this site or any services offered by this site. Your use of this site indicates acceptance of this privacy policy.

1. Driver hereby warrants to Passenger that he has obtained and maintains the required applicable motor vehicle license to operate the motor vehicle as set forth herein, and that he will, at his sole obligation and expense, continue to maintain such motor vehicle license throughout the term of this agreement.

2. **Optional language:** Driver shall not provide security, bodyguard or executive protection service as part of this agreement.

3. **Optional language:** Passenger hereby employs Driver under an at-will employment for no definite term and on the other terms and conditions set forth herein. Either party may terminate

the employment set forth herein, with or without cause and with or without notice, provided that Driver shall not provide less than fourteen day's notice of termination. In the event of termination by either party, neither party shall retain any obligation to the other except that Passenger shall remain liable to pay for services previously rendered pursuant to this agreement, and Driver shall remain liable to return the vehicle to Passenger if same belongs to Passenger. 4. **Optional language:** The first ninety days of employment shall be considered a trial period during which Passenger evaluates Driver's suitability for personal at will employment for Passenger. Completion of this trial period does not guarantee continued employment for any term.

5. **Instruction:** Parties should set forth whose vehicle will be used during the term of this agreement, the make, model, year and VIN number of such vehicle. The parties hereto represent the Vehicle has been inspected and is good working condition, has the appropriate inspection and registration, both of which are in effect and are not expired. [Comment: Parties should consider adding applicable information regarding who's responsible to maintain and repair vehicle.]
